

PREPARATION OF PAPERS

Each abstract of paper shall be in size no more than two pages (Size A4), printing area in each page shall be within 145mm*200mm, and capital letters are required for the title and subtitles of the paper. Chinese author name, if translated into English, shall be expressed in Chinese Pinyin, in the order of first name (the first letter capitalized, no separation) and then surname (all letters capitalized). All measurement units used in papers must be Chinese legal measurement units or SI units, and attention shall be paid to use correct capitalized and small letters. Visit the website or download instructions for specific format of papers.

PREPARATION OF POSTERS

Preparation of poster (max. allowable dimension):
120cm height x 90cm width
Font size of letters in abstract title shall be no less than 2.5cm in height,
Title / Author / Organization
Font size of English letters in abstract text shall be no less than 1cm in height
All lines in graphic shall be no less than 1mm, and font size of letters shall be no less than 5mm in height.

PROCESS OF SUBMITTED PAPERS

All authors whose papers are submitted will receive the enrollment notice and the notices of registration and payment before 31 August 2017; these authors shall prepare well their orals or posters. Rejected papers will not be returned, so a copy shall be reserved when submitting papers to BCEIA for all authors.

The conference fee must be transferred to BCEIA Finance Office before 15 September 2017 (the date of bank receipt shall prevail), and it is not guaranteed to enroll your paper in the published collected papers if you make an overdue payment.
